Judge Bray was undaunted by the overrun . Yet this budget fails to address the sagging roof structure of the courthouse, which is estimated to cost \$702,000, and has been characterized as urgent by an engineering team."

Their financial planning is giving way while fortunately the courthouse roof has not yet collapse on top of them"
